PAND-3906	Symptom: Server certificate untrusted error is returned when device certificate is renewed/changed in PCS and the profile is connected without closing the client. Condition: Connect to PCS Server after changing/renewing the device certificate in PCS. Workaround: Close and open the Pulse client and then connect the profile.
PAND-3874	Symptom: Rekeying is not working for 6in6 connection when data transfer is going on. Condition: Connect to PCS Server using IPv6 URL and do data transfer. Workaround: None.
